3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Jackie Robinson Com-
5	memorative Site Act".
6	SEC. 2. JACKIE ROBINSON BALLPARK NATIONAL COM-

(a) DEFINITIONS.—In this Act:

1	(2) SITE.—The term "Site" means the Jackie
2	Robinson Ballpark National Commemorative Site

4	(3) STATE.—The term "State" means the State

7	(1) In General.—The Jackie Robinson Ball-
8	park in Daytona Beach, Florida, is designated as
9	the "Jackie Robinson Ballpark National Commemo-
10	rative Site".
11	(2) References.—Any reference in a law,
12	map, regulation, document, paper, or other record of
13	the United States to the ballpark referred to in
14	paragraph (1) shall be deemed to be a reference to
15	the "Jackie Robinson Ballpark National Commemo-
16	rative Site".
17	(e) African American Civil Rights Network.—
18	The Site shall be part of the African American Civil
19	Rights Network established under section 308402(a) of
20	title 54, United States Code.
21	(d) Administration.—
22	(1) Cooperative agreements.—The Sec-
23	retary may enter into cooperative agreements with
24	appropriate public or private entities for interpreta-
25	tive and educational purposes related to the Site.

1	(2) Effect of Designation.—The Site is not
2	a unit of the National Park System.
3	(3) Limitations.—Nothing in this Act author-
4	izes the Secretary—
5	(A) to interfere with the rights of any per-
6	son with respect to private property or any local
7	zoning ordinance or land use plan of the State
8	or any political subdivision of the State; or
9	(B) to acquire land or interests in land
10	through condemnation or other methods.
11	(e) Special Resource Study.—
12	(1) In general.—The Secretary shall conduct
13	a special resource study of the Site—
14	(A) to evaluate the national significance of
15	the Site; and
16	(B) to determine the suitability and feasi-
17	bility of designating the Site as a unit of the
18	National Park System.
19	(2) Alternatives.—In conducting the study
20	under paragraph (1), the Secretary shall consider al-
21	ternatives for preservation, protection, and interpre-
22	tation of the Site by the Federal Government, State
23	or local government entities, or private and nonprofit
24	organizations.

1	(3) APPLICABLE LAW.—The study under para-
2	graph (1) shall be conducted in accordance with sec-
3	tion 100507 of title 54, United States Code.
4	(4) Report.—Not later than 2 years after the
5	date on which funds are made available to conduct
6	the study under paragraph (1), the Secretary shall
7	submit to Congress a report that describes—
8	(A) the results of the study; and
9	(B) any recommendations of the Secretary
10	with respect to the Site.
